Agreement for Sale and Purchase has been signed.

## 2. On the First Date of Sale:

### 於出售首日：

2.1 Balloting will be used to determine the order of priority in which the persons interested in purchasing the specified residential properties (the “registrants”) may select and purchase the specified residential properties. Details are as follows.

2.2 To participate in the balloting, each registrant must first submit a Registration of Intent. The form of Registration of Intent is available for collection at Sales Office 2. The manner for the submission of the Registration of Intent and the documents and materials required, etc. are specified in that form. Please refer to the form of the Registration of Intent for details. The order of the submission of a Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties. Notwithstanding anything as may be specified in the Registration of Intent:

(a) In addition to copies of specified identification document(s), each Registration of Intent shall be submitted together with such number of cashiers’ order(s) equal to the number of specified residential property(ies) the registrant intends to purchase as indicated in the Registration of Intent. The amount of each cashiers’ order shall be HK\$100,000. Each cashiers’ order shall be made payable to “Mayer Brown JSM”.

(b) A completed Registration of Intent shall be submitted to Sales Office 2 during the period from 18 January 2018 to 26 January 2018 (from 11:00 a.m. to 8:00 p.m.). An official receipt will be issued to the registrant in respect of a validly submitted Registration of Intent.

(c) Each person or company (whether alone or jointly with others) shall only be registered under not more than two (2) valid Registrations of Intent. If a person or company is registered under two Registrations of Intent, the name(s) of the registrant under the two Registrations of Intent must be the identical, and the two Registrations of Intent are referred as “**Related Registrations of Intent**” or “**Related Registration of Intent**”. Registration under more than (2) valid Registrations of Intent will not be accepted. Late submission will not be accepted. The Registration of Intent is personal to the registrant and shall not be transferable.

2.3 A registrant shall (personally or through a duly authorized attorney of that registrant who shall produce the original Power of Attorney duly signed by the registrant and the original identification document of that attorney (the “**Attorney**”) to the Vendor’s satisfaction and the Vendor reserves the right to accept or reject any Attorney and the Vendor’s decision shall be final) report attendance at Sales Office 1 during the period from 1:00 p.m. to 2:00 p.m. on the First Date of Sale (“**check-in period**”). The following must be produced for attendance registration: (i) (for individual registrant) the original official receipt for Registration of Intent and original identification document(s) of the registrant; OR (ii) (for corporate registrant) the original official receipt for Registration of Intent, a copy of Business Registration Certificate, Certificate of Incorporation and the most updated annual return of the company and the company chop. Registrants whose identities have been confirmed and verified by the Vendor shall be eligible for the balloting. Registrant who arrives at Sales Office 1 beyond the check-in period shall not be eligible for balloting.

登記人須（親身或透過其妥為授權之獲授權人（「**獲授權人**」）（獲授權人須出示登記人妥為簽署之授權文件正本及該受權人之身份證明文件正本達致賣方滿意程度，賣方保留權利接納或拒絕任何獲授權人，而該決定為終局。））於出售首日下午1時至下午2時（「**報到時段**」）於售樓處1報到登記。進行報到登記需出示 (i)（如登記人為個人）購樓意向登記之正式收據正本及登記人身份證明文件正本；或 (ii)（如登記人為公司）購樓意向登記之正式收據正本、公司的商業登記證、公司註冊證明書及最近的周年申報表副本及公司印章。登記人經賣方確認並核實身份後方可享有抽籤資格。登記人於報到時段以外的時間到達售樓處1將不獲抽籤資格。

2.4 After the verification of identities of the registrants, balloting will be carried out at Shop 1, G/F, 90 Hoi Bun Road, Kwun Tong (or if such venue is not available at such other venue arranged by the Vendor) (“**Balloting Venue**”). The Vendor reserves the right at any time, for the purposes of maintaining order at the Balloting Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time of the balloting. Each Registration of Intent shall be allotted

with one lot. The balloting results will be announced and/or posted by means as the Vendor considers appropriate at the Balloting Venue and/or Sales Office 1. Registrants will not be separately notified of the balloting results.

2.5 After the end of the balloting, the selection of the specified residential properties will take place at Sales Office 1. Registrants shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to the result of balloting, provided that if a registrant holds two Related Registrations of Intent, the order of priority of the Related Registration of Intent having a later order of priority will be promoted to the same as the Related Registration of Intent having an earlier order of priority and the original order of priority of the Related Registration of Intent having a later order of priority will become void and null. A registrant must in respect of a Registration of Intent select one or two (and not more) specified residential property(ies) in an orderly manner and within reasonable time. Where a registrant is, for whatever reason, not able to select any one or two specified residential property(ies) in an orderly manner and within reasonable time as prescribed by the Vendor, the Vendor reserves the right to disqualify the registrant from selecting any specified residential property.

抽籤結束後將於售樓處1進行揀選指明住宅物業。登記人根據抽籤結果之順序揀選當時仍可供選擇的指明住宅物業，惟如登記人持有兩份關連購樓意向登記，獲得較後優先次序的關連購樓意向登記的優先次序將提前至與獲得較前優先次序的關連購樓意向登記一樣，而獲得較後優先次序的關連購樓意向登記的原有優先次序將變成無效。登記人必須就一份購樓意向登記有秩序地及於合理時間內揀選一個或兩個（亦只限最多兩個）指明住宅物業。若登記人因任何原因未能有秩序地及於賣方規定的合理時間內揀選任何一個或兩個指明住宅物業，賣方保留權利取消登記人揀選任何指明住宅物業之資格。

2.6 The following provisions apply to selection and purchase of specified residential properties:

(a) The applicable number of cashiers' order(s) submitted with the Registration of Intent will be encashed to settle part of the preliminary deposit(s) of the specified residential property(ies) purchased (the balance to be paid by cheque(s) - please bring along blank cheque(s)). If the number of specified residential properties a registrant purchases is more than the number of cashiers' order(s) submitted, the registrant shall submit on spot one cashiers' order (of the same payee and amount as a cashiers' order submitted with the Registration of Intent) in respect of each such extra specified residential property to settle part of the preliminary deposit of that extra specified residential property (the balance to be paid by cheque(s) - please bring along blank cheque(s)).

An individual comprising that registrant is a Permitted Outgoing Person if that person is a relative of any individual comprising that registrant and who remains as an individual comprising the purchaser.

(d) All the purchasers shall sign the Preliminary Agreement(s) for Sale and Purchase of the selected specified residential properties.

(e) In this paragraph 2.6, "relative" of a registrant shall mean a spouse, parent, child, parent-in-law, child-in-law, grandparent, grandchild, sibling, parent's sibling, nephew or niece of the registrant or any person comprising the registrant provided that the registrant must provide the relevant supporting documents to the satisfaction of the Vendor to prove the relationship(s). The Vendor's determination as to whether there is such a relationship shall be final.

2.7 After the selection and purchase of specified residential properties by the registrant(s) as aforesaid has been completed, the sale of any remaining specified residential properties will be on a first come first served basis. The Vendor does not accept any person interested in purchasing having queued up before the commencement of such sale.

2.8 The Vendor also reserves its right to adjust the time of the check-in period, any balloting or selection of residential properties in accordance with the progress of confirmation and verification of identities of registrants or carrying out other procedures.

2.9 The Vendor reserves the right to close Sales Office 1 at any time if all the specified residential properties have been sold out,

2.10 If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of

11:00 a.m. and 8:00 p.m. on any date on which the Registration of Intent may be submitted and/or the first date of the sale, then, for the safety of the registrants and the maintenance of order at Sales Office 1 and/or Sales Office 2, the Vendor reserves its absolute right to change the date(s) and/or time (including the closing date and/or time) for submission of Registration of Intent and/or the check-in period and/or the balloting and/or the First Date of Sale to such other date(s) and/or time as the Vendor may consider appropriate and/or to close Sales Office 1 and/or Sales Office 2. Details of the arrangement will be posted by the Vendor on the website ([www.theastro.com.hk](http://www.theastro.com.hk)). Registrants will not be notified separately of the arrangement.
